## **FREE TAX FILING (if you earned less than \$48,362 in 2013)**

**Anaheim Community Services, Legal Aid Society of OC, United Way and IRS are providing the ability to file your taxes online free by appointment only. Personal assistance is not provided.**

**When:** Saturdays in 2014: 2/1, 2/8, 2/15, 2/22, 3/1, 3/8, 3/15, 3/22, 3/29, and 4/5.

**Time:** 10:00 am to 2 pm (Call to make an appointment)

**What to bring:** Proof of Identity, SSN or Individual Tax ID # for everyone on tax return, copies of all forms (W2, 1099, interest savings), child care provider ID #, bank info for direct deposit (voided check or deposit slip), last year's tax return.
